**RECOMMENDATION TO THE CITY COUNCIL
REGARDING AMENDMENT TO THE GENERAL PLAN**

MAY 18, 2006

PROPOSAL TO AMEND THE GENERAL PLAN TO INCLUDE THE EASTERN GOLETA VALLEY WITHIN THE CITY OF SANTA BARBARA'S SPHERE OF INFLUENCE, PROVIDE TEXT DISCUSSION OF LAND USE ISSUES IN THE GENERAL PLAN LAND USE ELEMENT, AND PRE-ZONE THE AREA (MST2006-00160)

The City is proposing this General Plan Amendment (GPA 1-06) in response to the Committee for One's pending application before the Local Area Formation Commission (LAFCO) to expand the City of Santa Barbara's Sphere of Influence. The area proposed for inclusion within the City's Sphere is the unincorporated area between the City of Santa Barbara and City of Goleta's jurisdictional boundaries, excluding the existing mobile home parks. The proposal would pre-zone the subject area to reflect existing County zoning designations.

WHEREAS, the Planning Commission has held the required public hearing on the above proposal.

WHEREAS, nine people appeared to speak in favor of the application, and no one appeared to speak in opposition thereto, and the following exhibits were presented for the record:
