A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SANTA BARBARA RESTRICTING PARKING UPON  
CERTAIN STREETS FOR THE PURPOSE OF STREET  
SWEEPING

WHEREAS, the Vehicle Code of the State of California provides that local authorities may, by ordinance or resolution, prohibit or restrict the parking or standing of vehicles on designated streets or highways, or portions thereof, for the purpose of street sweeping;

WHEREAS, the sweeping of residential streets is one of the six program elements identified in the Creeks Restoration and Water Quality Improvement Program adopted by the City Council of Santa Barbara; and

WHEREAS, sweeping creates cleaner, safer and more aesthetic streets, provides a safer environment for cyclists, prolongs the life of City streets, reduces pollutions in storm water and urban runoff, and is intended to improve creek water quality.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SANTA BARBARA AS FOLLOWS:

SECTION 1. For the purpose of street sweeping, parking may be prohibited on certain streets as deemed necessary within the areas designated on the map attached hereto as Exhibit A, Street Sweeping Zones dated June 1, 2006, on the days and hours determined by the Transportation Manager.

SECTION 2. Said parking prohibitions shall not apply on all City-observed holidays and on days when street sweeping is canceled by the Street Maintenance Supervisor due to inclement weather.

SECTION 3. The Transportation Manager shall place and maintain signs giving notice of the affective designated streets and times to be swept.

SECTION 4. This Resolution shall supersede Resolution Number 04-040.
