**SUBJECT:** Assignment Of Contract With The Santa Barbara Rape Crisis Center  
To The Santa Barbara County Victim Witness Program

### RECOMMENDATION:

That Council authorize the assignment of Santa Barbara Rape Crisis Center Human Services Contract No. 22,384 in the remaining amount of \$9,985 for the period January 1 – June 30, 2008, to the Santa Barbara County Victim Witness Program for operation of the Sexual Assault Response Team (SART) Program.

### DISCUSSION:

As of January 1, 2008, Santa Barbara Rape Crisis Center will be transferring supervision and oversight of the Sexual Assault Response Team (SART) Program to the Santa Barbara County Victim Witness Program. The Santa Barbara County Victim Witness Program falls under the direction of the Santa Barbara County District Attorney's Office.

SART is a countywide coalition of 21 public and private agencies which has been in existence since 1986. SART serves child, adolescent and adult survivors of sexual assault/abuse by providing forensic interviews, medical-legal exams, medical treatment and follow-up referrals and emotional support to survivors and their loved ones. The City of Santa Barbara has supported this program through its Human Services funds since Fiscal Year 2002, first under the umbrella of Child Abuse Listening Mediation (CALM) and currently under the umbrella of Santa Barbara Rape Crisis Center. The City portion is approximately 15% of the program's total operating budget.

As the SART program has grown and become more complex, the coalition members have sought ways to continue to provide high quality and efficient services to survivors of sexual violence who report the crime to law enforcement or Santa Barbara County Child Welfare

Services. The decision to move the oversight of the program to the County Victim Witness Program was made with great thought and in consultation with all of the 21 coalition partners, who fully support it. The SART coalition partners have determined that the infrastructure provided by a county department would better serve the needs of the program. District Attorney, Christie Stanley has accepted this transfer of responsibility. Megan Rheinschild, Santa Barbara County Victim Witness Program Coordinator, will be directly responsible for the supervision of the program.

The Human Services contract allows for assignment with City approval. We are recommending that City Council authorize the assignment of Santa Barbara Rape Crisis Center's Human Services Contract #22,384 and the remaining \$9,985 to Santa Barbara County's Victim Witness Program. The contract is for the operation of the Sexual Assault Response Program through June 30, 2008.

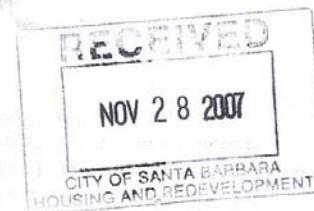

The decision to transfer SART's oversight from SBRCC to Santa Barbara County Victim Witness will affect contract #22,384 that SBRCC has effected with the City of Santa Barbara for FY 2007-2008 Community Development and Human Services funding. Please let me know what steps we need to take to transfer the contract and related responsibilities to Santa Barbara County Victim Witness.
