JOINT CITY COUNCIL AND SANTA BARBARA BOARD OF EDUCATION MEETING (150.05)

1. **Call to Order and Roll Call**

Mayor Marty Blum called the joint meeting of the Council and the Santa Barbara Board of Education to order at 1:37 p.m.

Discussion:

Staff made a presentation on the results of research conducted to identify excess City-owned properties, including residual City interests that could affect various Santa Barbara School District properties within the City limits, recommendations and next steps. Staff responded to questions from the Council and Board members.

By consensus, the Council and Board members directed their respective staff to move forward with the recommendations outlined in the report.

13. Presentation on School District and City Ballot Measures Scheduled for the November 4, 2008, Ballot

Discussion:

Santa Barbara School Districts Superintendent J. Brian Sarvis made a presentation on the measures placed on the November 4, 2008, ballot by the School Districts. Measures H2008 and I2008 pertain to a proposed parcel tax to support student achievement in the High School District and Elementary School District, respectively. If approved by the voters, effective July of 2009, Measure H2008 will impose a parcel tax of \$23 per year for 4 years, and Measure I2008 will impose a parcel tax of \$27 per year for 4 years. Finance Director Robert Peirson made a presentation on a measure placed on the November 4, 2008, ballot by the City of Santa Barbara. Measure G pertains to an update to the City's existing Utility User's Tax (UUT) on telecommunications and video services. If approved by voters, Measure G will reduce the tax rate from 6% to 5.75% for all City residents who use "land line" telephone service, cell phones, cable TV, and similar video services. Staff answered questions from the Council and Board members.

Mayor Blum left the meeting at 2:30 p.m. Mayor Pro Tempore House presided for the remainder of the meeting.

Administrative Services Director Marcelo López made a presentation on the goals of the Short-Term Summer Program Committee and the program's results. He also spoke about the goals and recommendations of the Long-Term Strategy Steering Committee. He also presented information related to next steps. Santa Barbara School Board Superintendent Dr. J. Brian Sarvis spoke about the proposed Gang Program Outreach Specialists and mentioned that this will be discussed at the next School Board meeting. Staff responded to questions from the Council and Board members.
