**SUBJECT:** Interviews For City Advisory Groups

**RECOMMENDATION:** That Council:

- A. Hold interviews of applicants to various City Advisory Groups; and
- B. Continue interviews of applicants to November 18, 2008, at 4:00 p.m.

**DISCUSSION:**

Interviews of applicants for 73 positions on City Advisory Groups are to be held on November 11, 2008, at 4:00 p.m. Applicants will also have the option to be interviewed on November 18, 2008, at 4:00 p.m. and November 25, 2008, at 6:00 p.m.

Applicants to the Franklin Center, Lower Westside Center and Westside Center Advisory Committees, and the low income neighborhood representative positions on the Community Development and Human Services Committee will have the option to be interviewed by a Council Subcommittee, instead of the City Council, on Thursday, November 13, 2008, at 7:00 p.m. at the Westside Community Center.

For the 73 current vacancies, 96 individuals submitted 110 applications. A list of eligible applicants and pertinent information about the City Advisory Groups is attached to this report.

Applicants have been notified that to be considered for appointment, they must be interviewed. Applicants have been requested to prepare a 2-3 minute verbal presentation in response to a set of questions specific to the group for which they are applying.

Appointments are scheduled to take place on December 16, 2008.
