AN ORDINANCE OF THE COUNCIL OF THE CITY OF SANTA BARBARA APPROVING A LICENSE (RIGHT-OF-WAY) AND AN AMENDMENT TO RIGHT-OF-WAY WITH SOUTHERN CALIFORNIA GAS COMPANY, TO PROVIDE FOR THE REALIGNMENT AT SANTA BARBARA AIRPORT OF CERTAIN PORTIONS OF AN EXISTING GAS PIPELINE

THE COUNCIL OF THE CITY OF SANTA BARBARA DOES ORDAIN AS FOLLOWS:

SECTION ONE. That the License (Right-of-Way) granted by the City of Santa Barbara, a municipal corporation, to Southern California Gas Company, a California Corporation, dated October 28, 2008, to provide for the realignment at Santa Barbara Airport of a portion of natural gas pipeline relocated at the request of the City of Santa Barbara to make way for the now completed Airport Runway Safety Project, and providing for the abandonment in place of superseded portions of said gas pipeline and related facilities located and described with specificity within the License recorded on May 16, 1963, as Instrument No. 21323, in Book 1992, at Page 747, of Official Records, in the Office of the County Recorder, County of Santa Barbara, State of California, portions of which pipeline are also depicted and implied but not described with specificity therein, is hereby approved pursuant to the City Charter of the City of Santa Barbara, and the City Administrator is authorized to execute the same.

SECTION TWO. That the Amendment to Right-of-Way granted by the City of Santa Barbara, a municipal corporation, to Southern California Gas Company, a California Corporation, dated October 28, 2008, to provide for the realignment at Santa Barbara Airport of a portion of a gas pipeline relocated at the request of the City of Santa Barbara to make way for the now completed Airport Runway Safety Project, and providing for the abandonment in place of superseded portions of the gas pipeline and related facilities located within the right-of-way reserved in the deed to the City of Santa Barbara recorded on April 9, 1941, as File No. 2773, in Book 521, at Page 326, of Official Records, as restated in the Agreement recorded on June 14, 1971, as Instrument No. 17836, in Book 2351, at Page 294, of Official Records, both in the Office of the County Recorder, County of Santa Barbara, State of California, is hereby approved pursuant to the City Charter of the City of Santa Barbara, and the City Administrator is authorized to execute the same.

SECTION THREE. That the realigned locations of the gas pipelines are located as specifically described and set forth in the said License (Right-of-Way) and the said Amendment to Right-of-Way, and all superseded portions of licenses at Santa Barbara Airport, as may have been described in such other recorded instruments, shall be vacated and abandoned automatically without additional action by Southern California Gas Company upon its acceptance and recordation of said new License (Right-of-Way) and said Amendment to Right-of-Way in the Official Records, in the Office of the County Recorder of said County.

SECTION FOUR. That upon the effective date of this ordinance, the City Clerk is authorized to transmit a certified copy of such ordinance together with each the said License (Right-of-Way) and the Amendment to Right-of-Way to Southern California Gas Company for its acceptance, execution and recordation in the Official Records, in the Office of the County Recorder of said County.
